2009 Club Membership Rules and Regulations

- Initiation fee is \$4000. (*non-refundable*)
- Dues for a single membership will be \$430 per quarter. This includes golf privileges for ***one*** person.
- Dues for a non-resident single membership will be \$380 per quarter. This includes golf privileges for ***one*** person. A non-resident must permanently reside outside of Brunswick County, and all adjoining counties, for a period of six months or greater each year.
- Dues for a family membership will be \$495 per quarter. This includes spouse and any dependants under the age of **23** that are currently in school. The dependant will lose membership privileges at **18** if they do not continue their education. This includes golf privileges, under the same family guidelines.
- Dues for a non-resident family membership will be \$415 per quarter. This includes spouse and dependants under the age of **23** that are currently in school. The dependant will lose membership privileges at **18** if they do not continue their education. This includes golf privileges, under the same family guidelines.
- Tee times may be booked no more than thirty days in advance. In order to book a tee time up to six months in advance, the number of members must be equal to or less than the number of guests.
- Members will receive 20% off regular priced merchandise in the Golf Shop. They will also receive 10% off food in the snack bar and restaurant. ***Discount does not apply on clubs or alcoholic beverages.***
- Cart fees are \$17 per person for (18) holes and \$9 per person for (9) holes. There will be a reduced fee for guests playing with the member.
- Members may pre pay their Cart fees:
Single - \$1500 annually (must be paid by January 15)
Family - \$2250 annually (must be paid by January 15)
This is on top of your dues. (Trail Fee)
- Walking is permitted, with some restrictions:
 - January 1 – March 31 after 12:00 pm Monday thru Friday
 - April 1 – May 20 after 1:00 pm Monday thru Friday
 - May 21 – September 10 after 1:00 pm Monday – Friday
 - May 21 – September 10 after 1:00 pm Saturday and Sunday
 - September 11 – December 31 after 12:00 Monday thru Friday
 - ***Weekends not listed Members may walk after 3:00 pm***

Walking is not permitted on the following holidays:

 - New Year's Eve
 - New Year's Day
 - Good Friday
 - Easter Monday
 - Memorial Day
 - Independence Day 4th,5th
 - Labor Day and Labor Friday
 - Thanksgiving Day and Friday

2009 Rates and Fees

Members will be issued a membership card and must present their card in order to receive golf and dining discount privileges.

Resident Golf Member

- Single Membership** - \$430 (four equal payments of \$430 payable in the months of January, April, July and October totaling \$1720 annually)
- Family Membership** - \$495 (four equal payments of \$495 payable in the months of January, April, July and October totaling \$1980 annually)

Non Resident Golf Member

- Single Membership** - \$380 (four equal payments of \$380 payable in the months of January, April, July and October totaling \$1520 annually)
- Family Membership** - \$415 (four equal payments of \$415 payable in the months of January, April, July and October totaling \$1660 annually)
